

# REPORT ON ELIGIBILITY – DIVISION OFFICE

Below is a report on the eligibility of all slates/candidates who accepted nomination as a Division Officer and submitted a ‘Notice of Candidacy Nominating Form’ and the optional ‘Slate Form’ to the Elections Committee by the end of the third business day after their respective Nominating Meeting. Pursuant to the TWU Local 100 2009 Election Rules and in accordance with the TWU Constitution and the Local 100 By-Laws, members in continuous good standing and have met the requirement for Union Meeting attendance could be nominated, to serve as Division Officers, at their respective April Division meetings. Almost 200 members were duly nominated and most have opted to run with the Union-wide slates.

All candidates were checked for membership status and attendance. (Good standing is defined by the TWU Constitution Article 13, Section 3, as dues paid for twelve (12) months continuously, no later than the fifteenth of any month.) All candidates disqualified (indicated in this report by an asterisk \*) were notified and had the right to a review and hearing before the Elections Committee and an appeal to the Neutral Monitor.

Any group of members could have submitted the optional slate form in a timely fashion and met the requirement for a slate : a Chair, at least one Vice – Chair, and a Recording Secretary - except in Conductor/ Tower where the recording secretary is elected at the section election. Disqualification of a member or members who were an integral component of a slate have caused the Election Committee to dissolve that slate. The remaining members, unless they have notified the EC of their intent not to run, will be designated as Independent candidates, having no affiliation to any slate, on the ballot (represented in this report with #). Any party who has not already done so and wishes to contest the determination of the neutral monitor has three days from this report to appeal to the TWU International Committee on Appeals.
