- NOTE 1** System Maintenance: Will report to Signal Supervision at the Signal Shop 207th Street Yard and may be required to perform related field work system wide. Generally repair, test and inspect signal relays, repair heavy equipment material handing and all other aspects of shop work.
- NOTE 2** Utility Capital Construction: Will report to supervision at the location selected and work as assigned system wide, performing Signal Construction and repair & renewal of switches, signals and allied equipment, cable, wire, messenger, power locations, transformers, air lines etc. Personnel may be required to perform preventive maintenance.
- NOTE 3** Maintenance on signal and allied equipment system wide. They will assist in the covering of trouble when necessary. Make standard test of signal and allied equipment and perform signal and allied work within their qualifications. Will generally work tour picked. Emergency Response: Will report to supervision at the location selected and normally respond by vehicle system wide as directed. Generally required to respond to troubles and emergencies, test operate interlocking, perform inspections and tests, inspect compressors, drain air lines etc. May be required to perform Signal Preventive Maintenance as described in Note 5.
- NOTE 4** Capital Construction: Will report to supervision at the location selected and work as assigned in the Repair & Renewal of signal and allied equipment system wide. They will assist in the covering of trouble when necessary. Make standard test of Signal and allied equipment and perform signal and allied work within their qualifications. Will generally work tour picked
- NOTE 5** Maintenance: Will report to the location selected and perform preventive maintenance on signals, switches and allied equipment as directed by supervision system wide. They will assist in the covering of trouble when necessary. Make standard test of signal and allied equipment and perform signal and allied work within qualifications.
- NOTE 6:** Vacation Relief: Will normally work the assignments of employees on vacation or any other absence, and assume RDO's and tour being covered. When not covering vacations or absences will report as picked and receive assignments from supervision. Personnel may be required to change tours when selecting vacation coverage.
- NOTE 7:** Daily Relief: Will report to the location selected and perform signal maintenance as directed by supervision system wide. Personnel will perform preventive maintenance as described in Note 5.
- NOTE 8:** Reporting Allowance: Accountability will be determined by supervision and will be rotated monthly, encompassing full week periods. The accountable maintainer will receive reporting allowance in accordance with contractual agreements.
- NOTE 9:** Compressor Squad: Will report to the location on the job selection and perform signal maintenance as directed by supervision system wide. Personnel will generally maintain, inspect, repair and test compressors and allied equipment.
- NOTE 10** Commercial Drivers License Required: In order to select this job you need a valid permit from your State of residence. Reimbursement, if any, will be in accordance with contract in affect during pick. 90 Day qualifying period. Employees who do not meet Transit qualifications will be temporarily assigned to a vacant job until next pick. In addition see "Note: 13"
- NOTE 11** 90 Day Qualifying Period: Employee who fails to qualify will be temporarily assigned to a vacant job until next pick.
- NOTE 12** Certificate Of Fitness (Fire Dept.): Certificate required for testing air receivers (Fire Dept.)
- NOTE 13** Drivers license Required: A license must be obtained within 90 days. Employees who do not meet Transit qualifications will be temporarily assigned to a vacant job until next pick.
- NOTE 14** Holiday Coverage: Will be required to work all contractual holidays.
- NOTE 15** Holiday Coverage: Will be required to work Lincoln, Washington and Veterans Day holidays. Veterans requesting Veterans day off will be excused.

- NOTE 16** New Technology: Will report to supervision at the location selected and work as assigned system wide, performing maintenance, repair and testing of solid state code systems, train identity/storage systems, microprocessor equipment, programmable annunciators, over speed protection system, event recorders data download and playback and new technology systems as they are installed and other related equipment. Personnel may be required to perform signal preventive maintenance as described in Note 5 and generally work the tour picked
- NOTE 17** Confined Space Training: Employee must complete Confined space training conducted by EDT.
- NOTE 18**
- NOTE 19** Hazardous Waste Certificate Required: Employee must complete Hazardous waste training conducted by EDT.
- NOTE 20** Crane Operator Certificate Required: Employee must obtain a crane operator certificate.
- NOTE 21** Asbestos Handler Certification Required: Employee must obtain an Asbestos Handler Certification. They must pass an annual medical and respirator training.
- NOTE 22** Lock in: 50% of the repair and renewal jobs which are designated as "Asbestos handler certification required" (maximum of 24 locked in) will be designated as locked in for two (2) consecutive picks.
- NOTE 23** Lock In: 50% of the new technology jobs (maximum of 6 locked in) will be designated as locked in for two (2) consecutive picks.
- NOTE 24** When available, and as assigned by supervision, response to trouble and train service disruptions will be by vehicle.
- NOTE 25** Fork Lift Certificate Required: Employee must obtain fork lift qualification certificate.
- NOTE 26** Employees may be required to perform both "Relay" and "Heavy Duty" functions.
- NOTE 27** Interlocking Squad: Will report to Signal Supervisor at the 215th street Signal shop and will be required to perform related field work on interlocking equipment system wide. Generally test, repair and inspect interlocking equipment
- NOTE 28** Lock in: 5 positions of the compressor squad jobs which are designated as "Asbestos handler certification required" will be designated as locked in for two (2) consecutive picks. (Pilot program). This pilot program shall be continued or eliminated after the second pick at the union or managements discretion.
- NOTE 29**
- NOTE 30** Employees will be off all contractual holidays.
- NOTE 31** Upon completion of the new Hunts Pt Facility, personnel from 125th St & Lex. and Westchester Yd will be required to report to the new maintainers' quarters at Hunts Pt.
- NOTE 32** Welding certification required. Employee must obtain a welding certification. They must pass a medical and respirator training.
- NOTE 33** Personnel will temporary report to ENY quarters until permanent facility is completed.
- NOTE 34** Personnel will temporary report to ENY quarters until permanent facility is completed.

LUNCH PERIODS: All lunch periods will be permitted between the 3rd and 6th hour of a tour of duty as determined by Supervisor.
