

# SIGNAL PICK NOTES 2017

## SIGNALS

<b>NOTE</b>	<b>GROUP APPLIES</b>	<b>NOTE DESCRIPTION</b>
1	215th Street Shop Personnel	Will report to Signal Supervision/Management at the 215 St. Signal Shop and may be required to perform related field work system wide. Generally duties include repair, test and inspect relays, repair heavy equipment, material handling, EMR, Compressor Squad, Test Squad, and Interlocking Squad.
2	Capital Construction	Will report to Signal Supervision at picked location and may be assigned to perform Signal related field work system wide. Generally duties include performing construction and repair & renewal of switches, signals and allied equipment, cable, wire, messenger, power locations, transformers, air lines etc. Personnel may be required to perform preventive maintenance.
3	SERT/SST	Will report to Signal Supervision at picked location and may be assigned to perform Signal related field work system wide. Generally duties include response by vehicle or train to disruptions and signal trouble. Test operates equipment, performs inspections and tests, inspect compressors, drain air lines etc. Personnel may be required to perform preventive maintenance as described in Note 5.
4	Capital Construction	Will report to Signal Supervision at picked location and work as assigned in the performance of signal construction, repair & renewal of switches, signals and allied equipment, cable, wire, messenger, power locations, transformers, air lines and testing of equipment. They will respond by vehicle or train to work sites, disruptions and signal trouble. Will generally work tour picked
5	Maintenance	Will report to Signal supervision at picked location and work as assigned in the performance of preventive maintenance and testing of signals, switches and allied equipment system wide. Test operates equipment, perform inspections and tests, replace components, inspect compressors, drain air lines etc. Generally duties include response to train interruptions and diagnosing signal related incidents.
6	CAT	Will report to a designated location with track department personnel. Generally duties include response by vehicle or train to disruptions and signal trouble. Test operates equipment, performs inspections and tests, inspect compressors, drain air lines etc. Personnel may be required to perform preventive maintenance as described in Note 5. Will be under the direct supervision of track department supervisor. Employees will still report to their respective signal sub-division office supervision and Management. CAT Signal personnel will adhere to all signal general rules & regulations, standards, policy and procedures.
7	Daily Relief	Will report to Signal supervision at picked locations and work as assigned in the performance of preventive maintenance and testing of signals, switches and allied equipment system wide. Test operates equipment, perform inspections and tests, replace components, inspect compressors, drain air lines etc. Generally duties include response to train interruptions and diagnosing signal related incidents.

# SIGNALS

NOTE	GROUP APPLIES	NOTE DESCRIPTION
8	Maintenance	The designated maintainer will receive reporting allowance in accordance with contractual agreements. Reporting allowance will be rotated monthly on sections which more than one maintainer reports on the same tour.
9	Compressor Squad	Will report to the location on the job selection and perform signal maintenance as directed by supervision system wide. Personnel will generally maintain, inspect, repair and test compressors and allied equipment.
10	Various	Commercial driver's license / Permint required. A permit must be obtained within 90 days. Employees who do not meet Transit qualifications will be temporarily assigned to a vacant job until next pick.
11	Various	90 Day Qualifying Period, employee who fails to qualify will be temporarily assigned to a vacant job until next pick.
12	Various	Certificate Of Fitness (Fire Dept.): Certificate required for testing air receivers (Fire Dept.)
13		
14	Various	Holiday coverage will be required to work all contractual holidays.
15	Various	Will be off contractual holidays with the exception of Lincoln, Washington and Veterans Day. Veterans requesting Veterans day off will be excused.
16	New Technology	Will report to supervision at the location selected and work as assigned system wide, performing maintenance , repair, and testing of solid state code systems, train identity/storage systems, microprocessor equipment, programmable annunciators, over speed protection systems and other systems which fall under the purview of New Technology Signals. Personnel may be required to perform signal preventive maintenance as described in Note 5 and will generally work the tour picked.
17	Various	Confined Space Training, employee must complete confined space training conducted by EDT.
18		
19	Various	Hazardous Waste Certificate Required: Employee must compete Hazardous waste training conducted by EDT.
20	Various	Crane Operator Certificate Required: Employee must obtain a crane operator certificate.
21	Various	Asbestos Handler Certification Required: Employee must obtain an Asbestos Handler Certification. They must pass an annual medical and respirator training.
22		
23	New Tech	Lock In: 50% of the new technology jobs (maximum of 6 locked in) will be designated as locked in for two (2) consecutive picks.
24	Various	When available, and as assigned by supervision, response to trouble and train service disruptions will be by vehicle.

<b>NOTE</b>	<b>GROUP APPLIES</b>	<b>NOTE DESCRIPTION</b>
25	215th Street Shop Personnel	Fork Lift Certificate Required: Employee must obtain fork lift qualification certificate.
26	215th Street Shop Personnel	Employees may be required to perform both "Relay" and "Heavy Duty" functions.
27	215th Street Shop Personnel	Interlocking Squad: Will report to Signal Supervisor at the 215th street Signal shop and will be required to perform related field work on interlocking equipment system wide. Generally test, repair and inspect interlocking equipment
28	215th Street Shop Personnel	Lock In: 5 positions of the Compressor Squad jobs which are designated as "Asbestos Handler Certification Required".
29	New Technology	Personnel will temporarily report to East New York quarters. During the course of the pick the reporting location may be changing to Corona Yard.
30	Various	Employees will be off all contractual holidays.
31		
32	Various	Welding certification required. Employee must obtain a welding certification. They must pass medical and respirator training.
33		
34	Maintenance	Personnel will temporary report to Times Square quarters until permanent facility is completed.
35	Various	Aerial lift training, Employees must complete aerial lift training
36	Various	Respirator; Employee must pass an annual medical and respirator training
37		
38	Capital Construction	Maybe required to work pass regular tour or have an early start with a direct report as needed.
39	215th Street Shop Personnel	Lock in for (2) Interlocking Squad Jobs. They will be designated locked in for (2) consecutive picks.
40	Maintenance	Personnel will temporarily report to 57th St & Broadway quarters until 96th & 2nd Avenue quarters are available.
41	Maintenance	As directed by supervision, Maybe required to directly report to a location during Winter Operations Plans 4 and 5 or any modified versions of Plan 4 or 5. PPE required. Compensated as per contractual agreement.
42	Maintenance	Lock In: Gap filler job locked in for 2 picks for training and 90 day qualiifiing period.
