Director's Letter

I am happy to announce that at our last executive board meeting a couple of changes were introduced and passed in our quest to improve the lot of TWU Retiree Association members.

Change number one was that Effective June 1, 2019, all the benefits in our Hospital Stay Program will be doubled, the weekly hospital income will rise from \$150.00 to \$300.00 per week, and all other benefits will rise accordingly.

Change number two is that the Retiree Association will now cover the cost of your Defensive Driving course, see the listing of classes here at the Union Hall. For those of you who are unable to take advantage of the classes at the union hall, merely send us a copy of the course completion certificate and a copy of your payment receipt and we will reimburse you. This benefit is capped at \$25.00 per member, spouse is included if you have a family membership.

Our efforts are ongoing to aid in the completion of this project, so there is still time to contribute to this deserving effort if you choose.

CONTRACT

The contract expired on May 15,2019, we have asked President Utano to seek an upgrade in our retiree Vision benefits, which were last upgraded over 35 years ago. We have also asked that he seek to secure a transit pass for the MTA Bus retirees and cooperation from management in getting a bill passed to get the pension contribution refund for those who retired before 12/15/2005. As of this edition going to the printer, the contract is still in negotiations.

Prescriptions

By now everyone should have received their new prescription cards from CVS Caremark, if you have not received them call the MTA BSC at 646-376-0123 and request a new card. The big take away here is that the only thing that is changing is the name of the provider, the plan remains exactly the same.



RETIREES TURN OUT IN NUMBERS TO HELP QUILL FILM PRODUCTION

The Retirees Association sent out a mailing im March asking for Local 100 retirees to help out with the making of a full length documentary film on TWU founder, the great Michael J. Quill. Retirees responded in typical fashion, rallying around the cause and sending in contributions of between \$5.00 and a couple hundred. We also asked retirees who had special memories or interactions with Quill to send in their contact information. Many did.

Filmmaker Macdara Vallely has begun calling those retirees, and reports back that there is a treasure trove of material that might be used in the film.

The name of the film is "Mike Quill: Which Side Are You On?" That name was chosen because it is the title of a famous, fighting union song that Mike loved, and that was performed by folk singer Pete Seeger at his memorial.

To date, Vallely has produced a beautiful, emotionally charged trailer that provides a window into the kind of breakthrough documentary the Quill story can be.



John Meehan, Former Retirees Director, Passes


John Meehan, retired Director of the TWU Retirees Association passed away on April 15, 2019 after a long illness. He was 80 years old.

R.S.S.L. Retirement & Social Security Law

REVISIONS IN PENSIONS

There are a few reasons, why your pension would or should be revised. The first reason is obvious. The Retirement sys-



tem either NYCERS or MaBSTOA discovered they made a mistake or you proved to the respective system that they made an error.

The second reason your pension would or should be revised is when you retire after a labor contract has expired and before it has been ratified.

In this case, if a wage increase is granted retro to the expiration of the old contract, then you the retiree; would be entitled to a contract increase from the expiration or rather the beginning of the new contract to your retirement date.


When the contract is ratified and you subsequently receive a check representing the back money owed to you from the effective date of the new hourly rate to your last day of pay(day before retirement date), you should make a copy of the check and bring it to your retirement system and request that NYCERS or MaB-STOA check to see if the retro check effects your Final Three Years Average(FAS).

If your best FAS is the last 36 months, the retro check will definitely increase the FAS and cause the respective retirement system to revise your pension retroactively to your retirement date.

If you FAS was 3 consecutive calendar years, the retro money can possibly make the last 36 months better and therefore cause a revision in your pension.

The bottom line is, when you receive money from your employer after you have retired, make sure NYCERS or MaBSTOA gets a copy of the check with a request from you, the retiree, asking that the retirement system look into the possibility as a revision in your pension. Don't depend on the retirement system to automatically do it.

The 3rd reason your pension would be revised is if you retired with an outstanding loan balance and now you pay it back. This is a subject for another newsletter.

Andy, a member of the TWU Local 100 Retirees Association, seems to be busier these days than when he was on the job.


He is spending his retirement years in Las Vegas, which among other things, is a golfer's paradise. That's a good thing since Andy is an avid golfer.



Below is an article that may be of interest to disabled vets:

Many Disabled veterans could receive a tax refund Some 130,000 veterans received notice last July that they may be eligible for federal tax refunds that they paid on disability severance pay.

The IRS notice was a result of the Combat-injured Veterans Tax Fairness Act (Public Law 114- 292), which was passed in 2016.

It affects veterans who received disability severance payments after January 17,1991 and included that payment as income in their tax returns.

The veterans who received notice have one year to file an amended return with the IRS. Claiming the standard refund is considered the most simple method for getting a refund.
