- ☐ Know what you are signing for as far as equipment serviced. **Do Not** let Foremen enter your work without a printout.
- ☐ Account for your time. Document all your equipment in the logbook; be able to explain what you did.
- ☐ The SEIS – Signal Electronics Information System (bar codes) – has a self auditing ability. The system will tell how long you worked on any piece of equipment, and if you did too much.

## Protect Yourself

- ☐ Your swipes can also be checked. Be aware this information can be used against you.
- ☐ The leadership of this union is standing behind our Signal Maintainers and helpers. **BUT, you must *Protect Yourself*.**

If you feel your rights are being violated, call your union first.
