Transport Workers Union Local 100- Runoff Election

Pursuant to a letter of agreement dated December 19, 2018, with Arthur Schwartz on behalf of Transport Workers Union Local 100, hereinafter referred to as “Local 100,” the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct a Runoff Election of Officers and Delegates at MTA Bus.

Two Thousand Two Hundred Sixty-Seven (2,267) ballots were mailed to eligible voters on Thursday, January 3, 2019. Local 100 provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator no later than 4:00 P.M. on Monday, January 28, 2019. During the course of administration, Three Hundred Eleven (311) duplicate ballots were sent out at the request of Local 100 voters.

The Administrator received a total of One Thousand Ninety-Three (1,093) ballot packets by the deadline scheduled. Of the packets received, seventeen (17) were set aside for the following reasons: 10 members not on eligibility list; 3 members sent back envelopes with no identifying information; 4 members sent back two (2) ballots. (*Envelope with the latest postmark was counted*) The counting of the ballots took place on Tuesday, January 29, 2019, at the offices of the Administrator and in the presence of observers.

The secrecy of the ballots was maintained at all times. The results are certified to be as follows:
