Transport Workers Union, Local 100
Re-Run Election for TA Surface Operators Division

Pursuant to a letter of agreement with Transport Workers Union, Local 100, the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct a Re-Run election for the TA Surface Operators Division. (Ballot #2)

Three Thousand Five Hundred Sixty-Six (3,566) ballots were mailed to eligible voters on Tuesday, January 4, 2022. Transport Workers Union, Local 100 provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator no later than 5:00 PM on Wednesday, January 26, 2022. The Administrator received a total of One Thousand Five Hundred Forty-Eight (1,548) ballot packets by the deadline scheduled. Envelopes were set aside before the count as follows:

- 7 Voters did not appear on the eligibility list
- 5 Set of duplicate ballots where more than one ballot was received from the same voter (Envelope with the latest postmark was counted)
- 34 Envelopes were challenged and left as unresolved as they were not determinative for any office

The counting of the ballots took place at 9:00 AM on Thursday, January 27, 2022, at the offices of the Administrator, located at 120 Broadway, Concourse Level, New York, NY 10271.

The secrecy of the ballots was maintained at all times. The results are certified to be as follows:
