General

- Universal pass for LIRR, Metro-North, NJT for family members too
- o EZ Pass for MTA Bridges
- o No broad branding
- o Additional protections for probationary employees (G&D table)
- No lay off clause
- o No farming out
- o Reduce time to top pay
- Involvement in procurement decisions
- Transfer leave balances
- Accrued pay time on pay stub
- o Right to pick across MNR, LIRR, SIRTOA and NIT
- Weekly paychecks
- Joint committee on ADA issues
- On-site childcare facilities
- o Increase money to Child Care Fund

Proposed Local Wide Demands

Grievance & Discipline

- o Eliminate requirement to provide MD lines (Leave table)
- o Eliminate home visits under SLCL and chronic
- Raise threshold for SLCL
- o Eliminate SLCL and discipline for chronic absenteeism
- o Add discipline tracks
- Increase look back on medical appeals to 90 days
- o Eliminate AWOL for late reports
- Right of TWU to appeal on behalf of member at Step 1 and Step 2
 hearings
- TWU to be informed of outcome of discipline of supervisors for harassment
- Change burden of proof from preponderance of evidence
- Increase late payment penalties
- Excuse lateness due to service disruptions on LIRR and MNR
- Increase time to submit sick forms
- Expunge mandatory retesting after one year
- o Penalties for unfair distribution of OT
- o TA to pay TWU's witnesses at disciplinary hearings
- Eliminate need to go to MAC if returning to work within 45 days

- Health benefits and health
 - Improve health benefits including optical and dental for Retirees, hearing aids
 - o Lifetime medical coverage for spouse if death before retirement
 - Raise Medicare Part B to national coverage
 - o 3D Mammograms covered (Women's table)
 - o Improve Hi Option
 - o Facilities for those who are nursing to express milk
 - Increase time and coverage for Cancer and wellness screenings
 - o Improve air quality in TA facilities
 - o Eliminate diesel powered equipment in shops and stations
 - Healthcare upon hiring
 - Braces for adults
 - No placement on FMLA while on comp
 - o More restricted duty jobs
 - Health club membership
 - o Back support as PPE

Proposed Local Wide Demands

Wages

- O Substantial wage increase continue raises above rate of inflation
- Eliminate health benefits deduction
- Increase DIF
- Increase longevity pay
- Cash out all unused sick leave when resigning, retiring or dismissed
- COLA for active and retirees
- o 10% night diff
- Improve Workers Comp benefits and procedures
- o Workers Comp pay in first pay period, when not contested
- MTA to match 401(k) and 403(b) at 20%
- \$20 meal allowance
- o Increase equity fund payment to maintainer titles to \$960
