DIRECTIONS TO DANTE CATERERS

- 1. FROM QUEENS & LONG ISLAND:** Long Island Expressway West or Northern State Parkway West to Grand Central Parkway West. Exit #7 LaGuardia Airport/94th Street. Left turn on 94th Street to 31st Avenue. Right turn on 31st Avenue to 75th Street.
- 2. FROM MIDTOWN MANHATTAN:** 59th Street Bridge Lower Level to Northern Boulevard (25A) East. Follow directions as in #5.
- 3. FROM THE BRONX:** Whitestone Bridge to Whitestone Expressway to Grand Central Parkway West. Follow directions as in #1.
- 3. FROM THE BRONX (ALTER-NATE):** Triborough/RFK Bridge to Grand Central Parkway East. Exit #5 Astoria Boulevard/Marine Air Terminal. Continue on Astoria Boulevard to 80th Street. Right turn on 80th Street to 31st Avenue. Right turn on 31st Avenue to 75th Street.
- 4. FROM BROOKLYN:** BQE East to Exit #41 (Northern Boulevard). Right turn on Northern Boulevard to 75th Street. Left turn on 75th Street to 31st Avenue. Right on 31st Ave. to Dantes.
- 5. FROM BROOKLYN (ALTER-NATE):** Belt Parkway East to Van Wyck Expressway North to Grand Central Parkway West. Follow directions as in #1.
- 6. BY TRAIN/BUS:** E,F,G,R or 7 train. All trains stop at 74th Street/Roosevelt Avenue/Jackson Heights. Walk North on 75th Street to 31st Avenue or take Q47 bus to Dante's.
