## INSTRUCTIONS FOR VOTING

SAMPLE BALLOT

Read the instructions before marking your **Ballot**.

- 1. Read the Ballot carefully before marking. The left side of the Ballot shows how many candidates you can vote for each position.
- 2. You have an option of either:
  - A) voting for a slate by marking an (X) in the slate box at the top of the column. The vote for a slate is counted as a vote for every member of the slate.
    OR
  - B) voting for individual candidates by placing an (X) in the box next to the candidate's name
- 3. IF YOU VOTE FOR A COMPLETE SLATE, UTILIZING THE SLATE BOX AT THE TOP OF THE BALLOT, DO NOT CAST ANY OTHER VOTE ON THE BALLOT
- **4.** This is a **Secret Ballot**. Do Not Sign or make any marks on either the **Ballot** or the **SECRET BALLOT Envelope**.
- 5. Place your marked ballot in the **SECRET BALLOT** envelope and seal it. Then place the sealed envelope inside the postage paid business reply envelope addressed to the **Transport Workers** Union Local 100, P.O. Box 25228, Brooklyn, NY 11202-9858.
- 6. DO NOT DAMAGE YOUR NAME OR ADDRESS OR CONTROL NUMBER CODE ON THE BUSINESS REPLY ENVELOPE. The Transport Workers Union Local 100 will use this information solely to verify your eligibility to vote in the election. The secrecy of your vote will be protected because the SECRET BALLOT envelope will be separated from the business reply envelope, and then mixed with the other SECRET BALLOT envelopes before they are all opened and counted.
