CERTIFICATION OF RESULTS

Pursuant to a letter agreement dated March 28, 2012 and signed by Earl Phillips of the Transport Workers of America Local 100, AFL-CIO, hereinafter referred to as "TWU Local 100," the American Arbitration Association, hereinafter referred to as the "Administrator," agreed to conduct a Delegate Election for Car Maintenance and a Conductor/Tower.

Six thousand nine hundred and thirty-one (6,931) ballots were mailed to eligible voters on Monday, April 16, 2012. As followed:

During the course of the election an additional thirty-four (34) packets were mailed at the request of TWU Local 100 members. To be counted ballots had to be received by American Arbitration Association no later than 8:30 a.m. Wednesday, May 16, 2012.

The Administrator received a total of one thousand five hundred and twenty-nine (1,529) ballot packets by the deadline scheduled. Of the envelopes received, three hundred and twelfth (312) envelopes were neither opened nor counted for the following reasons:
