Enforcing Labor Rights at LES

Management has been refusing to allow meal breaks for Local 100 members at Woodside CES who work four hours of overtime beyond their regular shifts. So LES Chair John Chiarello filed an Improper Practice Charge before PERB on May 14. Section 162 of the New York State Labor Law clearly states: "Every person employed for a period or shift starting before eleven o'clock in the morning and continuing later than seven o'clock in the evening shall be allowed an additional meal period of at least twenty minutes between five and seven o'clock in the evening." The hearing is set for July 8th in Brooklyn before Administrative Law Judge Philip L. Maier. We expect this to go to arbitration.

Back dues payments have gone up tremendously, with many members quick to pay their back dues and get on board with the new administration.

Seniority to be Honored in Structure Div ICC Moves

Your Structure Division leadership has come to an agreement with management in ICC. Seniority will be honored for all internal moves of members within ICC when a job is winding down.

Called for a Random?

If you are called to report to the MAC for a random drug test, make sure that the time on the form – showing when you were directed to report – is correct and reflects the time you leave for the MAC. There is no "two hour window." You're expected to report right away. Make sure you account for any delays along the way, including making note of train car numbers if you are delayed in transit.

Safety Form: A Key Enforcement Tool

Local 100's Safety Dispute Resolution Form is a tool that can be used to stop work if you believe that it is dangerously unsafe to proceed. Before we won the right to use this procedure, members who were forced to work in an unsafe manner or location were often brought up on charges of insubordination. The form gives any Local 100 member the authority to drive a safety complaint up the chain of command with the work stopped in the meantime. Chronic Illness? FMLA

Local 100 wants every member to know that there's a federal law protecting your right to take time off if you have a chronic illness. It's called the Family and Medical Leave Act (FMLA). For members, the FMLA can insure that you are not disciplined for taking sick time for a chronic illness. For more information, talk to your Union rep.

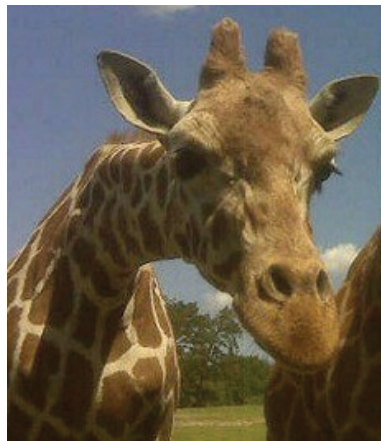
