Public Work

- Public Work Article 8, Section 220, NYS Labor Law
 - Under New York State Labor Law, contractors and subcontractors must pay the prevailing rate of wage and supplements (fringe benefits) to all workers under a public work contract.

Prevailing Wage Rate

- The Prevailing Wage Rate is the level of compensation to be paid to a worker, laborer or mechanic, for every hour worked, on a public work.
 - rates in a locality are determined by virtue of collective bargaining agreements between bona fide labor organizations and employers of the private sector.

What is Public Work

Two conditions must be fulfilled in order for the provisions of Article 8 to apply:

- 1. A public entity must be a party to a contract involving the employment of laborers, workers or mechanics; and
- 2. The contract must concern a public work project.

NYCTA and MTA Bus are Public Works

- The MTA and its subsidiaries are State
 Authorities the MTA is a Public Entity.
- The construction, reconstruction and maintenance work done by in-house forces at NYCTA and MTA Bus are absolutely a public benefit.

Two Tier Reality

- Currently, in some cases Local 100 members are working side-by-side with contractors on Capital Projects being paid radically different wages for performing the exact same work.

 - CCTV Installation
