

Medicare eligible TWU retirees have been covered since Jan. 1, 2024 by the new top tier health care package negotiated by Local 100 leadership.

"There was some confusion at the beginning," says Retirees Association Director James Whalen.
"But, we have made a big effort to make sure our retirees understand the benefits of their great coverage under Aetna Options 1 and 2. Today, we only get a few calls a day from members about Medicare coverages. That's a big improvement."

Whalen and Retirees Association manager Barry Roberts, blame the "confusion" on two things:

- 1. City union retirees, most notably from the Teachers Union, filed a lawsuit against their union and the City of New York over changes to "traditional Medicare" in their contracts, and:
- 2. A small group of TWU retirees, calling themselves TWU100R, claimed our benefits had been reduced, and tried to draw a comparison of our benefits to the City Unions.

Both Whalen and Roberts believe that the "intentional misinformation" spread by the TWU100R has caused a lot of damage. Why? "Because this group used the TWU's good name as part of its group's branding, which created an impression, most likely intentional, that they were part of Local 100 or the Retirees Association. **They are not."** "They also spread more lies that our benefits have been diminished. They haven't" said Whalen and Roberts, "they remain outstanding. Our benefits are superior to the City unions."

Another fabrication coming from the TWU100R group concerns doctors or hospitals not accepting Medicare or Medicare Advantage, said Whalen. "Some doctors or hospitals go in and out-of-network quite often when insurance contracts come up for renewals or providers open up negotiations. This is nothing new."

Whalen pointed to the controversy in late 2023 regarding New York Presbyterian Hospital's threat to withdraw from Aetna. "This was successfully negotiated between the hospital and Aetna, and no one lost any services. This is an unfortunate part of the American health care system."

Even if one's doctor leaves the Aetna network, members can still be seen out-of-network at zero (\$0) cost to the retiree as if that provider was in network. The provider must be a Medicare A and B provider and bill the plan.
