**Instructions For Voting**

**Sample Ballot**

Read the instructions before marking your **Ballot**.

1. You may only vote for one (1) candidate.
2. **If you vote for more than one candidate, your vote will be invalid.**
3. Mark an “X” in the box next to the candidate’s name.
4. Do not place your name, initials, or any identifying information on the ballot. Ballots containing any identifying information will be voided.
5. Place your marked ballot in the **SECRET BALLOT** envelope and seal it. Then place the sealed envelope inside the postage paid business reply envelope addressed to the **Transport Workers Union Local 100, P.O. Box 25228, Brooklyn NY 11202.**
6. **DO NOT DAMAGE YOUR NAME OR ADDRESS OR CONTROL NUMBER CODE ON THE BUSINESS REPLY ENVELOPE.** The Elections Committee will use this information solely to verify your eligibility to vote in the election. The secrecy of your vote will be protected because the **SECRET BALLOT** envelope will be separated from the business reply envelope, and then mixed with the other **SECRET BALLOT** envelopes before they are all opened and counted. **ENVELOPES WITH DAMAGED VOTER INFORMATION WILL NOT BE COUNTED.**

No postage necessary if mailed in the United States. **THE TRANSPORT WORKERS UNION LOCAL 100, ELECTIONS COMMITTEE MUST RECEIVE BALLOTS VIA U.S. MAIL NO LATER THAN 8:30 A.M. ON, WEDNESDAY DECEMBER 6<sup>th</sup>, 2023, IN ORDER TO BE COUNTED. NO BALLOTS MAY BE RETURNED TO THE ELECTIONS COMMITTEE IN PERSON.**

In order to have his/her ballot counted, a member must be in good standing at the time of the tally of ballots on Wednesday December 6<sup>th</sup>, 2023 (**must have no outstanding dues arrears**).

Please make certain to follow the voting instructions, which are included on the reverse side of this form.
