### YOU WILL RECEIVE A REFUND

Dear Joe Sample,

As a Tier 6 member of the New York City Employees' Retirement System ("NYCERS"), you are required to pay contributions (plus interest for late payments) for all your pensionable earnings. As your pensionable earnings change, your contribution rate changes. Pensionable earnings also include overtime wages up to a maximum amount. In addition, pensionable earnings cannot exceed the Governor's salary.

The MTA recently conducted a review of the contribution calculations of MTA Tier 6 NYCERS participants for the plan years 2012 to 2021. Upon completion of the review, we have determined that your contributions exceeded the required deductions from your pay. You will receive a refund of **\$489.05**, which includes 5% interest compounded annually on the net amount owed to you. This payment will be issued in a separate payment from your regular paycheck on **May 23, 2024**. We apologize for the error.

Enclosed is a summary of the data used in the contribution calculations for the plan years 2012 to 2021. Contributions after 2021 are not reflected in this analysis. Any future periods will be subject to further analysis and correction, if necessary.

The MTA's Consulting Actuary, Milliman, was retained to review the data and calculations and to provide an online database where active employees can access more information.
