VOTING INSTRUCTIONS

Read these instructions carefully before marking your Ballot.

- 1. Read the Ballot carefully before marking. The left side of the Ballot shows how many candidates you can vote for each position.
- 2. Vote for an individual candidate by placing an (X) in the box next to the candidate’s name. **If you vote for more than one candidate, your vote will be invalid.**
- 3. This is a **Secret Ballot**. Do not sign or make any marks on either the **Ballot** or the **SECRET BALLOT** envelope.
- 4. Place your marked ballot in the **SECRET BALLOT** envelope and seal it. Then place the sealed envelope inside the postage-paid business reply envelope addressed to the American Arbitration Association.
- 5. **DO NOT DAMAGE YOUR NAME AND ADDRESS OR THE CONTROL NUMBER CODE ON THE BUSINESS REPLY ENVELOPE.** The American Arbitration Association will use this information solely to verify your eligibility to vote in the election. The secrecy of your vote will be protected because the **SECRET BALLOT** envelope will be separated from the business reply envelope, and then mixed with other **SECRET BALLOT** envelopes before they are all opened and counted.

MAIL NO LATER THAN 10:00 A.M. ON, WEDNESDAY, DECEMBER 10, 2025, IN ORDER TO BE COUNTED. NO BALLOTS MAY BE RETURNED TO THE AMERICAN ARBITRATION ASSOCIATION IN PERSON.**

In order to have his/her ballot counted, a member must be in good standing at the time of the tally of ballots on **Thursday, December 11, 2025 (must have no outstanding dues arrears)**.

Please make certain to follow the voting instructions, which are included on the reverse side of this ballot.
